In the News...

RU-486 Update

On 15 November 2004, the U.S. Food and Drug Administration (FDA) announced an important labeling change for Danco Laboratories labeling of Mifeprex (mifepristone, also known as RU-486). Mifepristone was approved in 2000 for the termination of early pregnancy, defined as 49 days or less, under a fast-track policy designed for rapid approval of life-saving experimental treatments for patients with lethal diseases, such as AIDS or cancer. According to FDA Commissioner Jane E. Henney, the decision to finally approve RU-486 was the result of "careful evaluation of the scientific evidence related to the safe and effective use of this drug." The regimen had not caused any fatalities and had been shown to be free from the risk of uterine perforation and complications caused by anesthesia in surgical interventions. The most commonly

reported side effects were abdominal pain and heavy menstrual-type bleeding for a short duration. However, since then, the FDA and Danco Laboratories have received reports of serious and sometimes fatal infections, bleeding, and ectopic pregnancies that have ruptured. These reports have led to the revision of the black box labeling.

The original black box warning only discussed the potential complication of incomplete abortion. The new information reminds health care providers that serious bacterial infection and sepsis may occur without the usual signs of infection, such as fever and tenderness on examination. Health care providers should be aware that prolonged, heavy bleeding may warrant surgical interventions. The label also warns that health care providers should be vigilant for patients with undiagnosed ectopic pregnancies (tubal pregnancies) as this condition may be missed by physical examination and ultrasound. Some of the symptoms of an ectopic pregnancy may mimic the expected

symptoms of a medical termination of pregnancy. Mifepristone is not effective for termination of these pregnancies.

For consumers, the Medication Guide states patients should contact their health care provider right away if they develop fever, abdominal pain, and heavy bleeding. Also, consumers are advised to take their Medication Guide to the emergency room or any health care provider they visit for the problem. This allows health care providers to understand that the patient is undergoing a termination of pregnancy, and assess risks associated with that condition.

- WHEREVER THERE IS AN AILMENT, THERE IS JESUS

I have been practicing retail pharmacy for the past eight years and as the years go by, I realize that GOD is incorporated in every cell of our body. His word manifests its life in regard to treating all ailments, present, past, and future.

There was a patient that had her anti-seizure medication filled for epilepsy. We began to talk and I learned that the epilepsy came from when she had a cyst removed from the temporal lobe of her brain. We began to pray that God would give her peace and easiness during her illness. I shared Matthew 17:14-18 about how Jesus healed a man believed to have a demonic spirit when He could have had epilepsy. Jesus healed the man and asked his disciples why they had so little faith. Over time, she began to have fewer and fewer seizures and has had a better sense of peace and happiness. She says it means so much to her that I came out and prayed with her in agreement that God's will be done.

Another patient recently had a stroke and she was scared that she didn't know who she was anymore because of the damage the stroke had done to the cognitive portions of her brain. So I shared that God knows every man creature and tree because He created these things in His image. I explained that

God knows her that intimately (Isaiah 40:26). We prayed that God would love her and wrap His arms around her and after we said the prayer she said she felt so much better despite being so sick with the stroke and other conditions.

Another patient had stomach problems in which she was constipated and nauseous. Neither the doctor nor the hospital could determine what was wrong with her. So I offered to pray with her putting my hand on the area of her stomach that was bothering her and prayed to God for healing (John 7:38). Each subsequent time I saw her not only did she not have any more stomach problems, but also she looked like she was more at peace with herself.

There was a patient whose hands were hurting because of carpal tunnel syndrome. She had to take strong pain medication to manage the pain. We talked and I held her sore wrist and said a prayer asking God to put life into the hand I was touching. (Ecc. 9:10) She later said that her hand felt better and she normally does not let people hold her hand, but when I touched her hand, she felt something special, like a warm feeling. Not only does God give life to hands, but to every bone in the human body. In Ezekiel 37:1-5, God's spirit speaks to a valley of dry

bones and these bones came back to life and thrived regardless of the ailment (e.g., arthritis, osteoporosis). God's word and spirit can breathe life into otherwise weak aching bones.

There was another patient who came into the pharmacy who had had two previous back surgeries which were unsuccessful. She experienced severe lower back pain along with numbness down both legs. She was scheduled to have a third surgery on a different section of her back. Before the surgery, I offered to hold her up in prayer and gave her 7 scriptures on healing (1 Peter 2:24, Isaiah 53:6, Psalms 107:20, Malachi 4:2. James 5:14. Matthew 4:24. Matthew 9:35). She had the surgery and said that the surgery was a great success because she has no more numbness in her legs. The doctor said that she could return to work in about 2-3 weeks. In Matthew 8:1, someone went to Jesus praying for healing for leprosy. At the time the passage was written, the term leprosy was used to describe a great many skin conditions. Jesus touched a man requesting healing and through the man's faith he was healed. If we ask Jesus to touch us on the inside and out He can heal any skin condition.

There is something in God's word for every ailment. In John 8:36, the Lord says the truth shall make you free. The more you know about the ailment and the part of the body it affects then you can apply this wisdom and knowledge in order to treat your condition. From here you can claim your healing through faith.

 (I obtained 6 hours credit on my pharmacy license requirements while


being blessed by good Christian teaching).

LETTER TO THE EDITOR

To the Editor, The Faith Script:

Two letters were written to the editor in the Fall 2004 issue of the Faith Script agreeing with the FDA's rejection of morning-afterpills for over-the-counter status. I too agree for many of the same reasons, but I must comment and expand on one of the statements made. "If indeed it (the morning-after-pill) prevents implantation of the fertilized egg, the use of it would in essence amount to an abortion.... On the other hand, if it prevents the occurrence of ovulation, it would be no different than standard contraception...."

Birth control pills, like morning-after-pills,

work in three major ways. By 1) preventing ovulation, 2) thickening cervical mucus to prevent sperm from traveling to the uterus, and 3) preventing implantation. This can be found in the prescribing information for all birth control pills, and the prevention of implantation is the primary mechanism of action for progestin-only contraceptives.

Since women can become pregnant on the pill, we know they can certainly ovulate. If they can ovulate, fertilization can occur and there will be a fertilized egg (which for me translates as "life") that will be unable to implant in the woman's uterus – a chemical abortion. Please, please re-look at the prescriber's information for these medications and then pray about it. I for one, conscientiously object to filling/dispensing/counseling on all medications of this sort.
