Bylaws Updates

The changes largely reflect the move to more electronic communication, clarifying processes that have been in place but were not clearly defined in the Bylaws (ie: historical precedence regarding time that Officers must sit off the board), and clarifying elections procedures (steps in the case of a tie vote and requiring the student Director to undergo the same review as a professional Director). The proposed Bylaws changes will be distributed electronically for review and comment prior to an electronic vote by the membership.
