

Comments:

- Activities intended to bolster membership retention this year have included:
- Nena has regularly been distributing lists of non-renewal professional members to the Board-board members have been asked to choose 4-6 people on the list and contact them to ask them to renew or find out why they have not done so and usually all of the names on the list are assigned. While I do not have statistics to show results, anecdotally these personal contacts appear to be having a positive effect in maintaining our current membership numbers. Also, lists from various meetings, i.e.: GMHC, Virginia Asso, 2016 APhA CPFI breakfast and 2016 APhA CPFI Student seminar have been and are being used to contact potential new members.
- At the APhA Annual meeting in March 2016, I was able to meet with Daniel Wilson, Kinbo Lee and Suzanne Hussar to informally discuss membership issues. Daniel, Kinbo and I mostly discussed ways that students could help with membership retention of students and recent graduates.
- Professional membership has increased by 15% since May of 2011, but has remained flat for the last 4 years-(440=2012 447=2016). Student membership has increase by 6% since May of 2011, but it has fluctuated significantly between 532 and 768. Student membership has also remained relatively flat for the last two years (532=2014 552=2016). Both professional and student membership is only slightly changed since last year (professional=455 vs 447 and student=520 vs 552).
- Nena was contacted by a Canadian pharmacist CPFI member, (Jessica Leavitt) who is interested in finding
 ways to recruit other Canadian pharmacists to join CPFI. I have reached out to her and asked if she would
 be part of the Membership committee.
- I plan to have at least two membership committee meetings via conference call in 2016-2017. Membership growth of professional members and student members is stable, but I believe that we need plans that will provide for continuous and steady annual growth (5 to 10%). I will ask the committee to set goals AND ways to accomplish them, that will stretch us. These goals will require that ALL of our leadership (not just the membership committee) be involved in the recruitment and retention of professional and student members.
