

Christian Pharmacists Fellowship International Student Chapter Advisory Committee Report

Dear CPFI Board of Directors:

We pray this finds you all well and blessed. In brief, our report includes follow up on changes to our committee, ongoing/completed activities, and our future goals for the SCAC.

Updates to Committee: Member Exiting

STUDENT CHAPTER ADVISORY COMMITTEE: Jessica Tegan Langdon and Pakou Remick, Co-Chairs

• Sara Bruner will be stepping down from the SCAC: Regional Directors Coordinator (RDC) position who has provided oversight for the regions and communicating with Regional Directors for the past 2 years. Currently there is no interest from the current regional directors or any nominations from the RDC for this position.

Ongoing/Competed Activities

- Attend quarterly NSC meetings as able
- Serve as a contact point and support for the NSC officers
- Provide support to student chapters and respond to questions via email
- Conducted SCAC committee meetings every 4-6 months

Together we have accomplished the following tasks this year:

- For the 2022 CPFI Hands and Feet Grant recipients, we have:
 - Obtained articles with project pictures from 3 of the 7 recipients and the poster presentation slide from 6 of the 7 recipients. The original due date was April 30th.
 - On May 5th: Emails were sent out for suggested poster edits to the student chapters that submitted on time along with this request for the written reports were requested from those that did not submit one yet. An email was also sent to the one student chapter for a request for both items. Deadline for posters and written reports for all is by May 10th.
 - One school was unable to fulfill the requirement to attend and therefore submitted a video to play instead at the CPFI Annual Conference.
 - Due to poster edits being requested from all schools submitted, we plan to make a template for students to consider following to help guide students with formulating these poster presentations and revising the requirement component and deadlines to the 2023 Hands and Feet Grant criteria
 - To increase awareness for the CPFI Hands and Feet Grant for this Fall 2023:

- We plan to submit this years' written articles for publication to our CPFI magazine for consideration.
- One of the co-chairs is facilitating the Interactive Student Poster Presentations which highlights how the Hands and Feet grant funds have been used at the annual conference. The hope is to educate both pharmacists and students what it is so this can be brought back to student chapters along with encouraging further participation in the silent action by both pharmacists and students.
- We are finalizing the winners for the student awards -the Dr. Manasseh Heeralall Student Chapter
 of the Year Award and the Dr. Fred Eckel Distinguished Student Award to be presented at the
 CPFI Annual Conference awards banquet on May 27th. There were no nominations for the Psalm
 145 Award obtained despite an extension given this year.
 - o Recipient names will be submitted to Keith Allhands and Nena Lindrose on May 10th.
 - Speeches to be completed and sent to Keith Allhands and Nena Lindrose by May 20th.

Sara Bruner, the Regional Directors Coordinator, will be stepping down from the SCAC as the Regional Directors Coordinator who has provided oversight for the regions and communicating with Regional Directors for the past 2 years. She would like to report the following from this past year:

- In the 2022-2023 year we have 7 regional directors, including the regions Mid-Atlantic, Southeast, South-Atlantic, Great Lakes, Central Plains, Southwest, and North-Pacific. These individuals have worked hard to increase participation in events this year such as See You at the Pole, the Global Missions Health Conference, and our 4th annual Operation Christmas Child shoebox packing competition between the CPFI school chapters. This year our winner was Wilkes University in Pennsylvania!
- We currently have 86 active chapters and hoping to continue increasing engagement and participation in the coming years.

Future Goals

Our goals for the student ministry moving forward:

- Streamline the role of the SCAC and fill in any gap areas found.
- Work on compiling a list of all standing documents utilized by student chapters and templates for emails along with streamlining deadlines for grants and awards.
- Organize all forms, student chapter bylaws that have been submitted, etc for future reference.
- Work on advertising the RDC position online/at the conference otherwise this role will be assumed by the SCAC until the position is filled.

Sara Bruner is currently putting together information/templates for the future RDC/SCAC to make it an easy transition prior to her leaving the position.

Lastly, the committee would like to thank Nena Lindrose for all her direction this past year.
