#### To Dispense or Not to Dispense?, Should That Even be the Question?

At the American Pharmacists Association 2016 Annual Meeting & Exposition, the National Student Council of CPFI hosted a seminar discussing the controversial and politically heated topic of a pharmacist choosing to deny medications based on moral grounds, or commonly known as conscious clause legislation. Sure, a pharmacist can deny filling a medication based on lack of clinical evidence, but what about moral evidence? What initially sparked the idea of doing this presentation was the recent decision in the court case of Stormans v. Wiesman that challenged the Washington State's Board of Pharmacy's mandate that all pharmacies must stock and dispense Plan B emergency contraception. It is important to note that there is a considerable amount of variability in the Christian community in terms of opinions regarding Plan B. Some Christians consider the point of viability (i.e., implantation) the dividing line between whether or not a medication is considered a contraceptive versus an abortifacient.





#### To Dispense or Not to Dispense Continued:

Other Christians believe that fertilization is where that

line should be drawn. Considering the above information, we decided to ask the question "To Dispense or not to Dispense, Should that even be the Question?"
