

In The News... Palm Beach Atlantic Student Given Carnegie Heroism Award

Joe Alaimo was sitting on the beach studying for an exam with a fellow classmate when he heard someone yelling from the ocean. "We looked at each other, I said, 'Are you a strong swimmer? Should we go out? Let's go." A 10-year-old girl, Abby, was saved by Alaimo that day. Alaimo then spent the next 6 days in the hospital with pneumonia and a kidney infection after rescuing the girl from a vicious rip current.

Alaimo, along with Kenneth Slade, the girl's uncle who died while trying to save her, were given Carnegie Awards for heroism at a ceremony at the Flagler Museum in Palm Beach, FL on Friday, November 4, 2005. "The hero award fund was established by turn-of-the-20th-century tycoon Andrew Carnegie. In a century, 8,902 civilian heroes have been recognized and \$27 million has been distributed to award winners," according to a local newspaper. Alaimo told his story to the paper, "After swimming far into the ocean, he took 10year-old Abby Slade from her father, David Slade who was tiring. 'I kept swimming, my left arm around her, trying to tell her everything would be all right. 'I was getting tired. I would look up and I wouldn't be any closer to the beach. That's when I knew I was in trouble.' I came to terms with the fact that I was going to die that day.' Alaimo tried swimming



parallel to the shore, but continued to weaken until someone took Abby from him. Even when his toes touched the sandy bottom, he couldn't move closer to shore. Finally, he was grabbed and pulled to the beach.



How My Faith Developed

Note from the Editor: After I heard the Joe Alaimo had received the Carnegie Heroism Award (see story above), I asked Joe if he would write a short testimony.

There are many days that mean something to people for one reason or another, such as December 25th or September 11. For me, it is March 21st because it was the day that I got a second chance at life. While I was

trying to help rescue one of two girls from the ocean, I became trapped in a rip current. When I thought I was not going to make it back, I started to prepare myself to die. Before I let go, by a miracle, I felt arms go around me to help me back to shore. As I look back at that moment, I feel that God was telling me that my job with His work on this earth was not over yet.

After I was brought back to shore, I was sent to the hospital to recover from pneumonia, dehydration, and extreme exhaustion. As I was recovering, Dr. Wahba, a professor at PBA School of Pharmacy, who did not know me, came and prayed for me. The love and compassion that he showed me that day really touched my heart and opened my eyes to Christianity for the first time.

Dr. Wahba still challenges me to learn and sets aside time in his busy schedule to be with me one-on-one to answer questions that I have about the Bible. And if you ever had me as a student in class, then you know I always have a bunch of questions to ask. What I have learned from my readings was reinforced by listening to the devotionals that are said in the beginning of class at PBA. These readings allow me to get a little more insight into the Bible. Even with this exposure, it was still hard to grow spiritually when I didn't know how it all began. The Ethics class at PBA that I took allowed me to learn all about the history of the Christian religion such as Moses, Abraham, and of course, Jesus. Not everyone knows about the story of Jesus and if I had gone to pharmacy school anywhere else, my heart would probably still be closed off to hearing the Word.

I am very grateful for Palm Beach Atlantic University allowing me to attend pharmacy school. But being a Christian school of pharmacy, sometimes the focus should not be just on strengthening one's faith but allowing some people to find it. As I am an example of it; I once was lost, and now I am found.

Good News! Many Pharmacists Oppose Law Requiring Filling of Emergency Contraceptives

In the last issue of the *Faith Script*, a Medscape international poll showed that only 22% of respondents felt that pharmacists should refuse to fill prescriptions that conflict with their personal beliefs and 77% felt that pharmacists should not refuse to fill prescriptions that conflict with their personal beliefs. However, Medscape admitted that they do not currently have a system that will allow them to capture responses from pharmacists only.

Medscape has now reported on results from a new survey of US pharmacists that showed that "69% of pharmacists [n=859 total] said they should have authority to refuse to fill prescriptions for emergency contraception" (EC). However, only 39% of respondents were against state laws that would require them to fill prescriptions for certain medications. Although 61% were in favor of laws requiring pharmacists to fill prescriptions, the majority thought that a pharmacist should have the option to refer a patient to another pharmacy if they found a prescription objectionable. This survey was completed shortly after four pharmacists in Illinois were placed on unpaid leave by Walgreens for refusing to fill prescriptions for EC because of moral or religious objections. Walgreens policy states that a pharmacist can refuse to dispense medications that violate their moral beliefs, except where state law prohib-

its, as long as they facilitate the prescription to be filled somewhere else. Due to the Governor of Illinois' emergency rule, Illinois state law requires pharmacists to fill all prescriptions. When those pharmacists involved in the survey were asked about the Walgreens case, 63% thought the four pharmacists should not have been placed on unpaid leave for refusing to fill the EC prescriptions with only 29% supporting Walgreens decision.

Islands. To make it more sensible I guess I must fill in some background.

Solomon Islands is in the SW Pacific, just a few degrees south of the equator (which means that it is hot and humid all year round). The country is mostly ocean, and lies about 1500 miles NE of the Australian mainland. There are about 500,000 people, scattered across a large archipelago of more than 900 islands. Our friends will know we are here presently in Solomon Islands (SI) by my working as the SI Government's "Chief Pharmacist"; though my official title is Director, Pharmacy Services Division, Ministry of Health.

The remit I hold is a national one, covering the development and implementation of national medicines policy; direction of national pharmacy human resourse development programs; oversight of public sector pharmacy services standards; oversight and direction of the national medical supply systems; medicines information activities; and all the administration and regulatory affairs that go with those matters. Serving in this way puts us incountry where Sylvia my wife, and I, are also able to give to, and work with, a local independent church and associated communities in different islands. We do this in various ways such as primary school teaching (Sylvia) who also does sewing and vocational training and English improvement. We encourage and help to provide Bible training, and I often work with small groups towards "community development." All of this is simply, in our view, "Christian living and working." Through these things we reach out to touch lives with light and love, and bring good news. Or, as many would say we "do outreach." By being here in the

capital we also are able to host others from various churches/ works, who visit SI for different kinds of service (i.e., we try to be hospitable where we can!).

Having shared all that - in which so many prayer needs might be implied! – what is our specific need for prayer at

and it needs to be renewed for a further two years. Time is running short. Not only does this need to happen in the next few weeks, we also need to have the Australian sponsor agree to it too – as that is where about 4/5ths of our allowances comes from in this placement. The status of the health and pharmacy services in SI is still

very fragile. While in some ways SI has recovered a long way from the ethnic inter-islands conflicts of 1998-2001, it is estimated that economic recovery is still so slow that it will take at least another ten years or more just to get the earnings for people back to their 1995 levels!! There is still a huge amount of work to do to bring services up to a proper professional, yet sustainable, standard. This is, in every way, a least-developed country. In this situation, you will appreciate that we feel we still have a role to play here, and certainly we do not feel any change in our sense of calling.

May we therefore ask folks to pray with and for us to be renewed (in every way!!), both as we take a break in Australia during Dec/Jan, and hopefully as we come back for a further period of fruitful service.
